How we will calculate your variable APR: We will add a "margin" to the U.S. Prime Rate to determine your variable APR. If the U.S. Prime Rate is not available or is not published, whether temporarily or permanently, we will select a substitute index that we believe, in our sole discretion, is similar to the U.S. Prime Rate. The U.S. Prime Rate is 5.25% as of 11/01/2018. The margin will be 9.74% for your Overdraft Line of Credit.

Billing Rights: Information on your rights to dispute transactions and how to exercise those rights is provided in your account agreement and the Overdraft Line of Credit Agreement.
